While we pressure the federal government to act, the provincial government must do more to reduce delays. The Province need to review policies that will decrease delays in the criminal justice system, or increase the speed of the civil justice system-thereby freeing up courtroom for time-limited criminal hearings.

Increasing the speed of the courts is a difficult task, and is not a responsibility that should be taken lightly. every change to the justice system has an equal and opposite reaction that can outweigh the benefits of the policy in the first place.

therefore, the province needs to effectively study its options before acting recklessly.
